### UNCONDITIONAL GUARANTY AGREEMENT

THIS GUARANTY is executed by the undersigned \_\_\_\_\_, (hereinafter sometimes the "Principal Guarantor"), who agrees to bind and to pay CAM Trading Inc. on demand any sum which may become due if the Customer Entity shall fail to pay the dues.

It is understood that D/B/A, (collectively the "Customer Entity"), a customer of CAM Trading Inc., ("CAM"), has applied to CAM requesting that CAM extend continue or renew credit, concerning all past, present and future obligations of the Customer Entity to CAM, as applicable, (collectively the "Extended Credit"), to the Customer Entity, of which the undersigned Principal Guarantor warrants and represents that the Principal Guarantor is the is the principal Member, Shareholder or Owner thereof of the Customer Entity and has the full authority to enter this agreement.

As a condition precedent to CAM's approval and acceptance of the Customer Entity as to the Extended Credit, the undersigned Principal Guarantor personally and unconditionally has been required to guaranty all past, present and future obligations of the Customer Entity with respect to the Extended Credit and all other obligations of the Customer Entity to CAM. The requirement of this Guaranty is in recognition that payment and performance of the Extended Credit, must be protected by the independent and additional financial means of the Principal Guarantor, and that CAM would not enter into a Extended Credit agreement with the Customer Entity in the absence of the present Guaranty. This Guaranty shall remain in full force and effect regardless of the financial means, or lack thereof, of the Customer Entity.

Guarantor does hereby jointly and severally guaranty the payment, in full, of any obligations under the Extended Credit to be executed by the Customer Entity and the performance of any and every obligation under said Extended Credit , expressly including, without limitation, the Guarantor responsibility to pay all attorneys fees incurred by the CAM in connection with any collection or enforcement action or actions under the Extended Credit and or Rules and Regulations.

This Guaranty may be fully enforced against the Guarantor without any requirement of first seeking recovery from Customer Entity or any other responsible party. Guarantor consents that any proceeding to enforce this Agreement or related rights may be brought in any court sitting in the judicial district or circuit in which CAM maintains a registered office, and Guarantor consents to Personal Jurisdiction of such court or courts and agrees he may be served with process by certified United States Postal Service mail sent to Guarantor at the address shown below, or any other address of the Guarantor. Any action or actions to enforce this Guaranty shall be governed by the Laws of the State of Georgia.

The Guarantor hereby waives: (1) renewal or notice of any extension or extensions of time within which any payment for damages or the performance of the obligations shall be due; (2) the necessity of recourse against the Customer Entity by CAM; (3) any understanding that any other person, firm or corporation was to sign this Guaranty; (4) the incapacity or bankruptcy of Customer Entity or any other guarantor or guarantors; or (5) any notice of change or amendment to this Extended Credit , the rules and regulations, or the right to any notice of default.

Any renewal of Extended Credit by the Customer Entity and CAM, or new Extended Credit s entered into between same, shall be subject to this Guaranty, and the Guarantor expressly consents to be bound to all future Extended Credit hold agreements between CAM and Customer Entity.

**THE EXECUTION OF THIS GUARANTY IS A MATERIAL INDUCEMENT FOR CAM TO ENTER INTO A EXTENDED CREDIT CONTRACT, AND CAM IS FULLY RELYING UPON THE DUE AND VALID EXECUTION BY THE PERSON OR PERSONS WHOSE NAME OR NAMES ARE SHOWN BELOW. CAM RESERVES ALL RECOURSE, EITHER CIVIL OR CRIMINAL, RESULTING FROM A FALSE OR INVALID EXECUTION HEREOF. THIS AGREEMENT SHALL REMAIN IN FULL FORCE AND EFFECT DURING THE TERM OF THE EXTENDED CREDIT, OR ANY SUBSEQUENT EXTENDED CREDIT BETWEEN THE CAM, OR CAMS ASSIGNS OR SUCCESSORS AND CUSTOMER ENTITY. IN THE EVENT OF RECOVERY AGAINST THE GUARANTOR, GUARANTOR HEREBY AGREES TO REEXTENDED CREDIT INFORMATION FROM ANY BANK, SAVINGS AND LOAN, EMPLOYER, AND ANY LENDER FOR COLLECTION PURPOSES AND FOR CAM TO RUN PRESENT AND FUTURE CREDIT CHECKS AND INQUIRIES ON THE GUARANTOR FROM TIME TO TIME DURING THE PENDENCY OF THIS AGREEMENT AND ANY RENEWALS THEREOF.**
